RESOLUTION NO. 25-04

**A RESOLUTION FOR THE CERTIFICATION OF ADDITIONAL STREETS TO THE
CITY OF ST. CLAIR ACT 51 LOCAL STREET SYSTEM**

WHEREAS, the City of St. Clair has noted that a portion of Stratford Road north of Hawthorne Road in the Palmer Village Subdivision No. 2 has not been included in the Act 51 local street system; and

WHEREAS, it is necessary to furnish certain information to the Michigan Department of Transportation (MDOT) to place these streets within the City of St. Clair local street system for the purpose of obtaining funds under Act 51, P.A. 1951 as amended.

NOW, THEREFORE, BE IT RESOLVED:

1. That the City St. Clair acquires Stratford Road north of Hawthorne Road and the center line of said street is described as:

COMMENCING AT THE WEST QUARTER CORNER OF SECTION 30; THENCE NORTH 90 DEGREES 00 MINUTES 00 SECONDS EAST 3016.81 FEET TO THE WEST LINE OF PALMER VILLAGE SUBDIVISION No. 2 AS RECORDED IN LIBER 57 OF PLATS, PAGE 21, ST. CLAIR COUNTY RECORDS; THENCE ALONG THE WEST LINE OF PALMER VILLAGE SUBDIVISION No. 2 NORTH 24 DEGREES 58 MINUTES 20 SECONDS EAST 425.17 FEET TO THE NORTHWEST CORNER OF PALMER VILLAGE SUBDIVISION No. 2; THENCE ALONG THE NORTH LINE OF PALMER VILLAGE SUBDIVISION No. 2 SOUTH 77 DEGREES 01 MINUTES 40 SECONDS EAST 554.07 FEET; THENCE SOUTH 25 DEGREES 24 MINUTES 22 SECONDS WEST 91.52 FEET TO THE POINT OF BEGINNING OF THIS DESCRIBED CENTERLINE; THENCE CONTINUING SOUTH 25 DEGREES 24 MINUTES 22 SECONDS WEST 128.06 FEET TO THE INTERSECTION OF THE PHYSICAL CENTERLINE OF HAWTHORNE ROAD AND THE PHYSICAL CENTERLINE OF STRATFORD ROAD ALSO BEING THE POINT OF ENDING OF THIS DESCRIBED CENTERLINE.

2. That said street is located within a City of St. Clair right-of-way and is now under the control of the City of St. Clair.
3. That said street is a public street and is for public street purposes.
4. That said street is accepted into the City of St. Clair local street system and open to public use on December 31, 2024.
